- 3 In collaboration with the Ministry of Justice Computer Training Classes for Judicial Officers were held at the Judges Training Institute, on Saturdays during the aforesaid period.
- 4 Advanced English Classes were conducted in the evenings on Saturdays at the Sri Lanka Judges Training Institute for the benefit of the original Court Judges with the assistance of the Sri Lanka Institute of Development Administration (SLIDA). during the aforesaid period.
- 5 A Two day Colloquium was held at the Earl's Regency Hotel, Kandy, for Magistrates and Additional District Judges selected mainly from the Central Province on 24th and 25th January 2009, on the subject of "The Provisions of the Domestic Violence Act No 34 of 2005"
- 6 A Two day Colloquium was held at the Club Palm Bay Hotel, Marawila, for Judges in the North Western Province on 5th and 6th June 2009, on the subject of "The Protection of the Environment"
- 7 A Two day Colloquium was held at the Chaaya Village, Habarana, for a selected group of Judges mostly from the Eastern, Northern and North Central province on 13th and 14th June 2009, on the subject of "The rehabilitation of Children recruited to Armed groups"
- 8 A Colloquium was held at the Ramada Resort, Kudawaskaduwa, for District Judges and Magistrates on 11th July 2009, on the subject of "Tsunami affected children"
- 9 A Colloquium was held at the Hotel Amaya Hill in Kandy, For Labour Tribunal Presidents and Additional Magistrates , on 18th and 19th July 2009, on the subject of "Concept of Justice and equity in Labour Tribunal Adjudications"

- 10 A Colloquium was held at the Holiday Inn Hotel, for Magistrates of the Western Province on 25th July 2009. on the subject of Intellectual Property Rights and Enforcement
- 11 Additional telephone facilities have been provided for the Judges of all Provinces in the Island including Northern and Eastern Provinces.
- 12 In addition a Telephone advisory has been made available to all the Judges of the Island inclusive of the Northern and Eastern Provinces by the Director (N.K.Udalagama) and Deputy Director (P.H.K.Kulatilaka). during the aforesaid period.
